## Participation

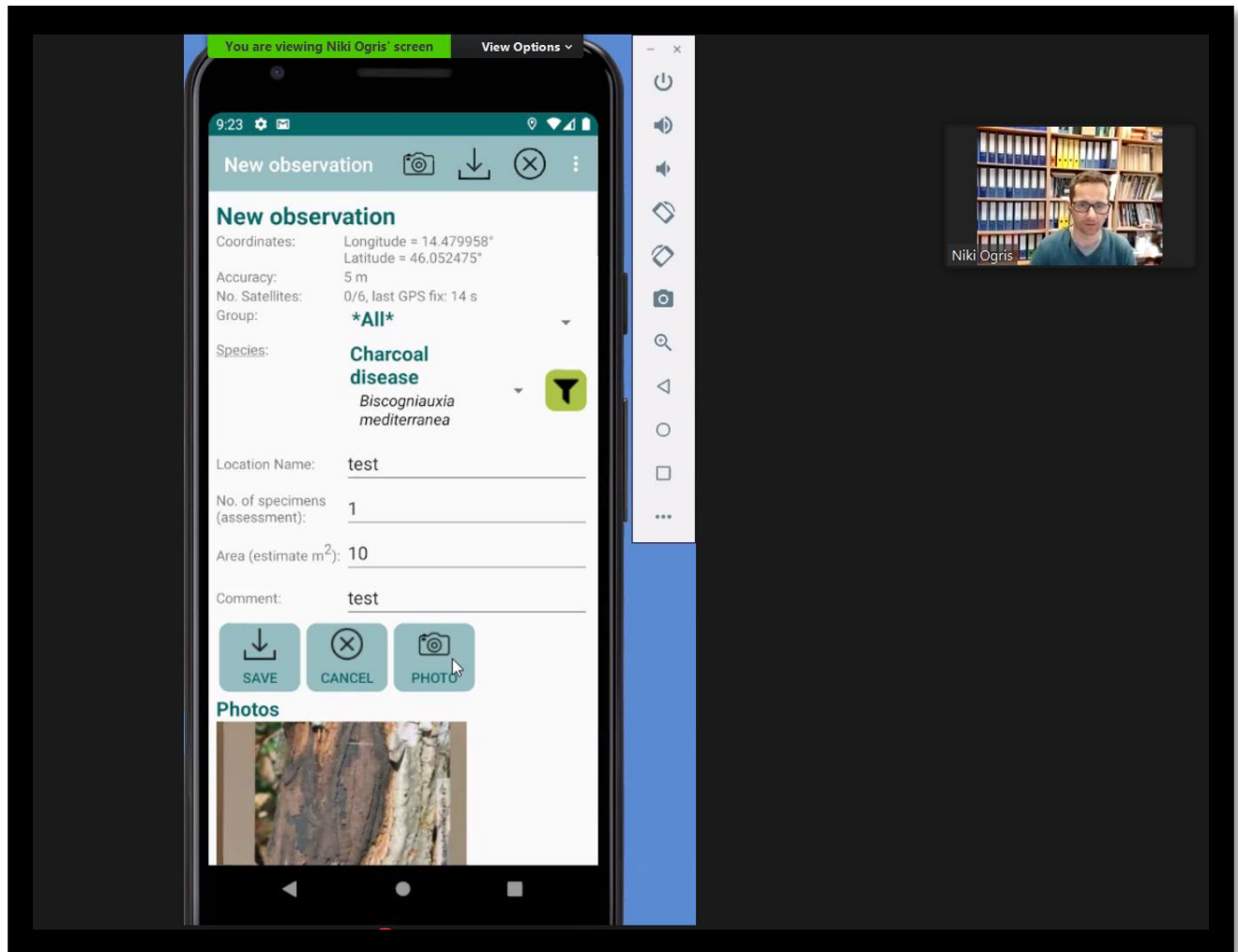

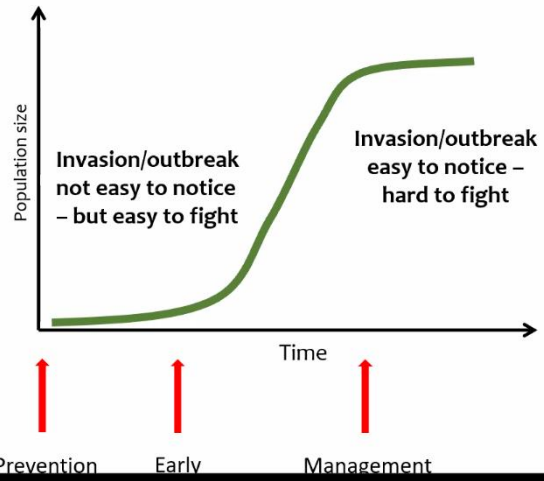
