## Methodology

The purpose of this guidelines is to provide the methodology for D.T3.2.2 “Implemented Regional Policy Dialogue”. The regional dialogues are focused in the circular (bio)economy and multi-level governance, both considered crucial developments to unleash revitalised rural areas and tackle demographic change. It also establishes a close link with: i) The “Danube Region White Paper”, published at the end of 2021 and summarised in a deliverable format via D.T3.2.1; and ii) D.T3.1.1 (Regional Policy Agendas) giving relevance to the mapped and future funding programmes in the participating regions.

The following activities described below should be addressed and completed by project partners **by end of September 2022**.

**Step 1:** Project partners from regions/countries, where contact details for D.T3.2.1 (Regional Ecosystem Mapping; information related to excel tables) were missing (Croatia, Romania, Slovakia), should check again at their Managing Authorities and Funding agencies (national or regional level – depends on project partner position), who is/are the responsible person(s) regarding circular (bio)economy.

**Step 2:** Project partners arrange meeting(s)/short interviews with the responsible person(s) identified in the first step. The aim of this task is to collect Managing Authorities’ and Funding Agencies’ feedback on the situation regarding circular (bio)economy in their region.

In order to do that, project partners should use the results and documents produced during the project so far, especially:

- DT3.2.1 Regional Ecosystem Mapping
- Good practices from WPT2

The questions for the discussion could be based on the findings and recommendations from DT3.2.1. The questions should be addressed to these topics:

1. Current situation in the Danube region and situation in project partner’ region in regard to circular (bio)economy with the emphasis on the gap between the EUSDR<sup>1</sup> and regional/national circular (bio)economy strategies. What is the feedback on the findings of the DT3.2.1? Project partners could also present the good case of Baden-Württemberg to trigger the discussion.
2. Link of national/regional funding programmes with EUSDR (interface EUSDR with mainstream programmes).
3. What is the outlook on funding programmes available in the coming months/years?
4. What is the status of interministerial collaboration in project partner’ region/country?
5. What is the level of the mutual exchange with Danube Region peers: any suggestion or advice for the Brain Trust?

6. Do you have some recommendations on Joint Governance? Generic recommendations are also welcome.
