YOUMIG - YOUTH MIGRATION IN THE DANUBE REGION

Young people are mobile. At certain turning points of their lives they are more likely to make big changes, even move from one country to another, for a shorter or longer period. It all depends on how you look at it: the same person can be an immigrant of one country, an emigrant of another, or even a return migrant, once they decide to move back home. The Hungarian Central Statistical Office, as lead partner, designed a project where research, data evidence and analysis support administrators in handling youth migration locally.

YOUMIG, in which 19 partners from 8 countries worked together, strived to support local governments in using the developmental potential of youth migration, which is to lead to a better governed and more competitive Danube region. The project boosted their institutional capacities to enhance the scarce local evidence on youth migration and to contribute to improved policymaking with a focus on human capital. Statistical offices and academic organizations teamed up with local governments in a complex and customized multi-level and transnational cooperation to create local developmental strategies based on improved impact indicators of youth migration and to introduce transnationally tested tools for managing local challenges. As a result, institutions and stakeholders obtained increased capacities through an intensified cooperation

ANALYSIS

The countries of the Danube region differ in their migration patterns. There are typical sending or host countries, while some places are mixed, and many countries see their natives coming home, too. A lot of information is already known about migration and population change and stories circulate about favourite destinations. But these are rarely collected on the local, city level. YOUMIG researchers prepared local analyses for each of the seven partnering localities involved as project partners to see how local communities are affected by the movements of their youth.

BETTER DATA

Statisticians are working hard to provide ever more accurate data on people's movements. But they need local information, local data sources and even the expertise of locals themselves to understand how to best measure such a complex topic as youth migration. YOUMIG brought statisticians and researchers together to select and in some cases redesign indicators — tools by which migration is measured.

BETTER LOCAL SERVICES

Cities are often judged by the services they provide to their residents. Migration puts administrative burdens on young people, who often don't know where to turn to with their questions. YOUMIG identified local stakeholders – administrators, teachers, politicians, concerned citizens – who each hold a piece of the puzzle with their knowledge about the needs of young people in different areas. Putting the puzzle pieces together, filling the gaps where necessary, means services can improve for the whole community.



TESTING WITH PILOTS

YOUMIG gave each partner municipality the chance to test an idea that stakeholders expected to be helpful in managing youth migration locally. With the aid of a Good Practices Guide offering examples which were successful elsewhere, YOUMIG partners each designed their pilot action.

Some of the ideas tested were:

- a virtual business incubator (Burgas),
- a mentoring programme for migrant girls who choose technical careers (Graz),
- co-working spaces and programmes boosting telework and creative entrepreneurship (Maribor and Kanjiža),
- an online platform to address potential returnees and their interests (Sfântu Gheorghe),
- sensitisation and multicultural trainings for preschool teachers (Szeged) and
- language courses for migrant communities (Bratislava-Rača).

INFORMATION AS ONE-STOP-SHOP

Young migrants are gravely lacking practical information. Once you are no longer a tourist, but need to integrate more into the life of a new community, information is hard to come by. YOUMIG's one-stop-shop was designed to collect all the information they need in one place.

STRATEGIES

YOUMIG believes youth migration is one of the important topics for any municipality in the 21st century. Strategies should be created, ideas mulled over and good solutions adopted. Each of the seven YOUMIG municipalities prepared a Local Strategy – collecting the most important lessons learnt from our project – into a practical handbook for decision-makers and stakeholders. The Local strategies were translated into several local languages.





DATA TOOLKIT

Each Local strategy comes complete with a DATA TOOLKIT — an Excel-based app that's easy to use and gives users quick information about migration in their locality with graphs, ready-to-print reports and more. YOUMIG held trainings for local council staff to make sure they understand how to use the data and how to update it in future to enhance the conversation and policy agenda on youth migration.

RECOMMENDATIONS FOR GOVERNMENT COOPERATION

Different branches of government and administration find it hard to communicate, especially when coordination on data or registers are involved. YOUMIG held several workshops to see where coordination could be improved and published some country-specific recommendations on how to improve the information flow.

NETWORKS OF KNOWLEDGE - THE YOUMIG PARTNERSHIP

More than 100 people took part in YOUMIG and even more people got involved indirectly in its activities. YOUMIG hopes this network of knowledge will stay alive after the days of the project, as a reliable source of information to ensure more evidence-based decision making for youth migration in the Danube region.
